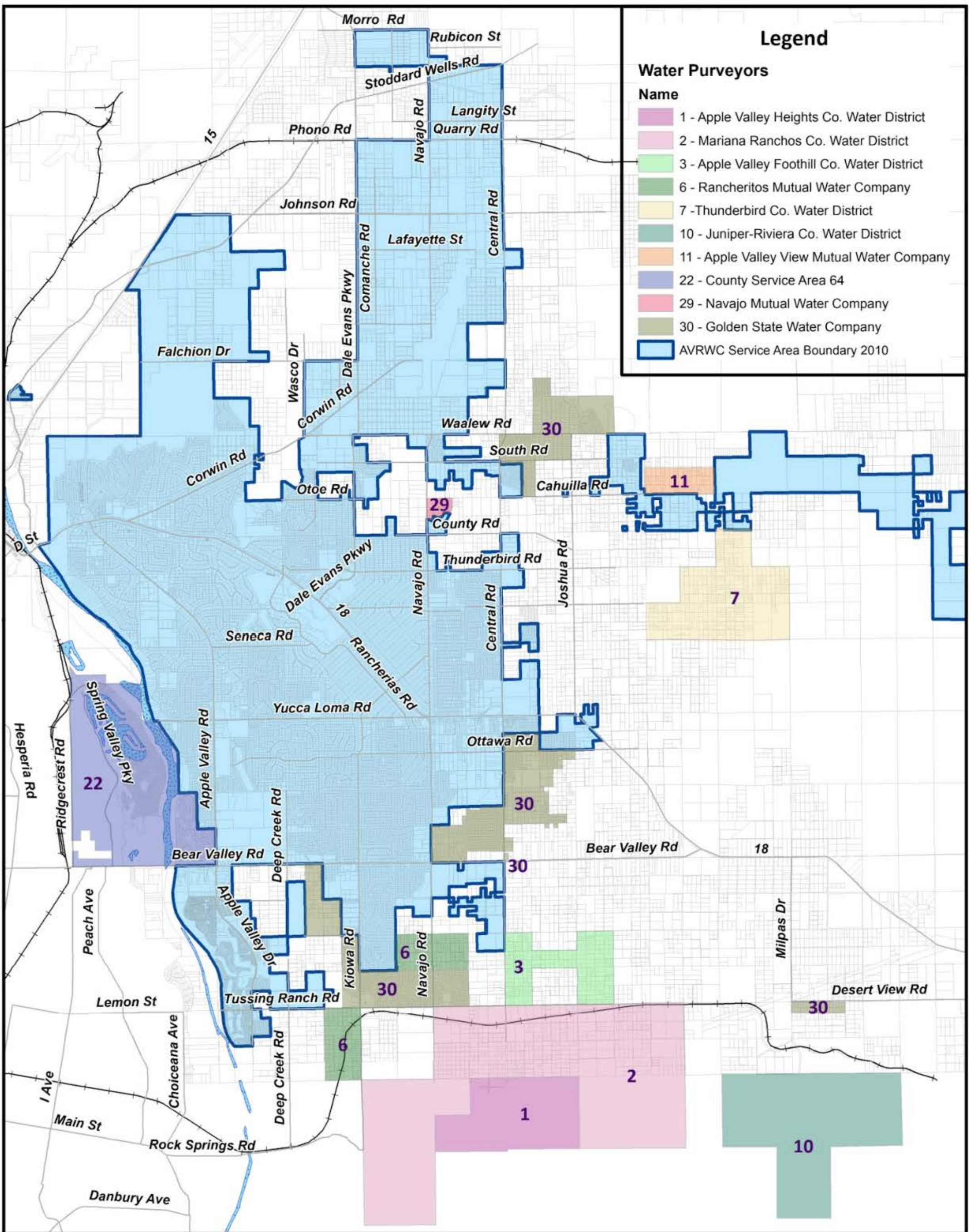

Bills are due upon presentation and considered past due if unpaid after 15 days after statement date. Late penalties are assessed after 30 days at \$20 and customers are given 60 days to pay amounts owed before their water service is disconnected. The fees for scheduled disconnection is \$50 and possible security deposit \$180 to unlock. A 24-hour drop box is located on the Northwest side of the office, left of the entrance at 9429 Cerra Vista Street, Apple Valley, CA 92308.
